Strategies for International Development (SID) develops, applies, and promotes better methods for eradicating rural poverty. We help small farmers make the transition from subsistence to successful commercial farming. We carry out programs in the poorest regions of Guatemala and Peru.

In Guatemala, in 2020, we continued our regional program in the Department of Alta Verapaz. We expanded the program to a third municipality (Cobán), adding 409 families and 24 new communities to the program. 1,107 families in 67 early-adopter communities increased their income from \$106 to \$438 a year from coffee. 90% of the women in these families participated more equally with their husbands in coffee businesses and 98% started second businesses. Furthermore, coffee farmers in all three municipalities (San Cristobal, Carcha, and Coban) increase their knowledge and adoption of the 8 practices for increasing productivity, the 7 for husking the coffee cherries and selling directly to exporters for a higher price, the 7 for conserving farmland, and the 6 business practices. Finally, because of COVID we spent the first half hour of every visit to communities on the practices for preventing the coronavirus, and then proceeded with our assistance in the practices for increasing income from coffee.

In Peru, in 2020, we continued to provide technical assistance to the dairy-producing families that receive loans from our micro-credit program. We helped farmer make business plans as well as improve their land-use plans. We provided technical assistance in the practices that improve the health and nutrition of their dairy cows. Finally, because of COVID we spent the first half hour of every visit to communities on the practices for preventing the coronavirus, and then proceeded with our assistance in the practices for increasing income from dairy.
